I acknowledge that hunting has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

- 1. The risk of handling firearms and being near others that have firearms in their possession.
- 2. The risk of injury from ammunition and shot from other guns.
- 3. Walking in rugged country, including encounters with wildlife, animals, and insects.
- 4. Inclement weather conditions.
- 5. The risk of injury from riding on an all-terrain vehicle (ATV) or any vehicle used off the paved road.
- 6. The risk of injury from the use of tree stands.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with MARK SLADE or _________(GUIDE INFO). I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have good physical conditioning and the degree of skill necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in the activity is purely voluntary. No one is forcing me to participate, and I elect to participate despite the risks. I AM VOLUNTARILY USING THE SERVICES OF REES 547 LLC D.B.A. FOXHEAD FARM WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

According to Georgia law, all hunters born on or after January 1, 1961, must complete hunter education certification to hunt in Georgia. Please sign below to confirm you have completed this requirement.

NO animal is important enough to justify an unsafe action.

- 1. Listen to your guide. There is no such thing as a stupid question. Our guides are experienced and will help you with any questions you have. Our goal is to give you an enjoyable experience in the field and for you to leave as friends instead of clients.
- 2. There are to be **NO LOADED WEAPONS IN THE BAY, LODGE, OR VEHICLES**. Vehicles include all ATVs and UTVs. If a live round is found in the chamber of your weapon in these areas, you agree to a fee of \$200 payable to Foxhead Farm. If this occurs a second time, the hunt is over for the offender.
- 3. KNOW YOUR WEAPON. Safeties and triggers are different.
- 4. Always know your target and what is behind it.
- 5. When hunting anything other than dove, turkey, or waterfowl, the display of hunter orange is state law. Its purpose is to keep you from being accidentally shot. It is to be always worn in the field.
- 6. Know the location of fellow hunters in your party. This makes for a more enjoyable as wells as safer hunt.
- 7. DO NOT SHOOT BIRDS ON THE GROUND OR WATER!!!
- 8. You are expected to have a valid Georgia hunting license while hunting off the preserve and to obey Georgia hunting laws.
- 9. Foxhead Farm has many poisonous snakes such as Diamond Back Rattlers, Timber Rattlers and Cottonmouth Moccasins. We recommend snake boots or snake gators or chaps.
- 10. Foxhead Farm has a moderately flat terrain. However, reckless use of 4-wheelers or large vehicles can result in death or injury. Our roads are not racetracks.
- 11. At Foxhead Farm we value our dogs immensely. We, and our guides, spend countless hours with them in and out of season. Therefore, replacing one is very expensive. The only way a dog can be shot and killed is out of negligence. The fine for shooting a dog is \$9,500 and ALL medical expenses. This fee also applies to the shooting of guides and staff.
- 12. Foxhead Farm staff and guides work hard to provide you with a pleasurable experience. Please help take care of them. Gratuity is expected and appreciated. If you think gratuity is not in order, please talk to MARK SLADE. This will help us correct problems and improve our service.
